

**SOMEBODY HELP US/ ALGUIEN AYUDENOS, INC.**  
**CORPORATE RESOLUTION**  
**August 28, 2018**

Article II of the Bylaws of the Corporation defines the **Purpose** of this entity as:

The purpose of the organization is to assist citizens and entities of San Juan and other Puerto Rican municipalities in the recuperation and reconstruction in the wake of Hurricanes Irma and Maria. These activities shall include, without limitation, the collection and distribution, among citizens and entities in Puerto Rico, of donations of any kind aimed to the fulfillment of the purpose of the organization. The donations collected by the organization shall be distributed in the following proportion: an amount equal or lesser to twenty five percent (25%) directed to citizens or entities located in Puerto Rican municipalities other than the Municipality of San Juan, where the remaining amount will be directed to citizens or entities located in the Municipality of San Juan.

WHEREAS, on a meeting held on August 28, 2018 the Board of Directors of the Corporation discussed the desire to modify the Purpose of the Corporation in order to expressly state that the objectives of the corporation extend to promotional initiatives of the efforts of collecting and distributing donations for the reconstruction and recuperation in the wake of Hurricanes Irma and Maria.


WHEREAS, the Board of Directors resolved to amend the Purpose of the Corporation to accordingly read as follow:

The purpose of the organization is to assist citizens and entities of San Juan and other Puerto Rican municipalities in the recuperation and reconstruction in the wake of Hurricanes Irma and Maria. These activities shall include, without limitation, the collection and distribution, among citizens and entities in Puerto Rico, of donations of any kind aimed to the fulfillment of the purpose of the organization; and the promotion and announcement of these efforts through general media, television, film or documentary productions or any other similar mean of mass promotion inside or outside Puerto Rico for the purpose of procuring additional donations. The donations collected by the organization shall be distributed in the following proportion: an amount equal to or lesser than twenty five percent (25%) directed to citizens or entities located in Puerto Rican municipalities other than the Municipality of San Juan, where the remaining amount will be directed to citizens or entities located in the Municipality of San Juan.

RESOLVED, that the Bylaws of the Corporation be amended and restated according to this resolution.
